Meeting Minutes-August 7, 2025

1. Call to Order

- a. The meeting was called to order by Jake Colletti.

2. Attendees

3. Treasurer Report

- a. Aneysa Guilliams presented the treasurers report.

5. Old Business

i. Sponsorship Banners

ii. Water Truck

iii. Tractor

iv. Concessions

1. Aneysa reported she only wants to replenish Hamburgers for the concession stand at this point in order to use the items we already have and not end up with a lot of overstock.

- v. Revision of By-Laws
 - 1. Wendy requested we amend the rule that states “riders under the age of 18 must be accompanied by their legal guardian while on RCC property” to instead say “Legal guardian or designee”. Aneysa Guiliams made a motion to accept the amendment and all other changes. The motion was seconded by Jay Guiliams. The motion passed.
 - 2. Discussion held about changing the requirements of the “family membership” to allow for youth living at home still in high school to be allowed to be on the family membership. It was reported this has already been discussed and voted against in a previous meeting and that decision will be upheld.
 - 3. Discussion held regarding “who enforces the bylaws” result of discussion was that “it is all members’ responsibility to help enforce bylaws”

 - 1. Megan Colletti was elected as the Chair of the Awards Committee.
 - 2. Buckles have been ordered for both gymkhana and sorting.
