Meeting Minutes- April 10, 2025

1. Call to Order

- a. The meeting was called to order by Jake Colletti at 6:18 PM.

2. Attendees

- a. The present board members, officers, and club members in attendance are listed in attachment #1.

3. Treasurer Report

- a. Aneysa Guilliams presented the treasurers report. Aneysa has created ledgers separating out all different revenue and expenditures to better organize and keep track of incoming and outgoing club money. The following amounts are the ending balances as of 04/10/2025:

4. Prior Meeting Minutes

- a. In the absence of Sam Baker, Cindy Schafer read the March meeting minutes. Jake Colletti made a motion to approve the minutes as read. The motion was seconded by Jay Guilliams.

5. Old Business

- a. Night of the Gymkhana
 - i. Stephanie Guilliams created a google survey to send out to club members to get feedback on changing the night the Gymkhana is held. Stephanie is going to post the survey on our Facebook page and send the link to Aneysa so she can email the survey out to all active club members. The survey deadline is set for May 1st.
- b. Outreach- Flyer to be sent out through the schools
 - i. Megan Colletti presented the flyer shown in attachment #2. The club would like to see the following changes made: QR code added, email address added, roping replaced with clinics, and Membership bonuses added. Jake Colletti made a motion to accept the flyer with the listed changes. The motion was seconded by Cindy Schafer. Once corrections are made, Megan Colletti will send the flyer to the District 70 admin building to receive approval to send the flyer out through the schools.

- c. RCC Saddle Club Phone Number
 - i. A phone number has been set up through Google voice for RCC Saddle Club. This is a free service that allows the calls to ring to multiple members' cellphones through an app. The club phone number is 719-225-2396. Jake and Megan Colletti will assist board members on setting up the app onto their phones if they wish to have it.
- d. Water Issues
 - i. Water availability at the arena was discussed and questioned whether we would be able to get running water back. It was stated that there was a water break in the main line running to the arena, and also there was no meter. Wallace volunteered to search for a new water truck that would allow us to drive to the fill up station.

6. New Business

- a. RCCSC Accounts- Authorized Users
 - i. Pauli Boyd made a motion to remove all previous authorized users on the Bank of the San Juan accounts and the Sam's Club account, including, but not limited to: Gay Christie, Ben Franciscotti, Kathy Lesser, Jesse Christie, Shannon Hassey, Red Anderson, Courtney Nugent, and Doug Osterman. The motion was made in order to remove members that are no longer serving on the RCC Saddle Club board. The motion was seconded by Aneysa Guilliams.

 - ii. Cindy Schafer made a motion to add Jake Colletti, Jay Guilliams, and Aneysa Guilliams as authorized users to the Bank of the San Juan accounts and the Sam's Club account. The motion was seconded by Pam Cozzetto.
Vote: Unanimous
- b. Communication Secretary
 - i. Jake Colletti appointed Megan Colletti as the communication secretary.
- c. Liability Waiver
 - i. Wallace had a lawyer review our current liability waiver and she made suggestion on a revised form. Jay Guilliams combined the two separate suggested forms the lawyer created, in order to have one liability form per membership. It was suggested by the club that additional signature/name lines will be needed for larger families and that we should require full legal

name, phone number and address be added. The club would also like to see the members initial page one of the waiver, and sign on page two. Jay is going to make the requested changes and email out a final copy to the board members for review.

d. Liability Signs

- i. Cindy Schafer made a motion to purchase a total of 10 liability signs to place around the arena grounds. The current liability signs do not meet state requirements. Cindy found the signs that meet the requirements on amazon and provided the links to Aneysa Guiliams for purchase. The motion was seconded by Jake Colletti.

e. Sorting Fees and Signup format

- i. Discussion was had regarding changing the sorting fees and signup format. Cindy Schafer suggested a flat rate fee be set that would allow each rider up to 10 rides. Each rider would line up and take turns. The club discussed this as a possible change, but decided to leave the sorting as is for the 1st event to determine the amount of interest we will have.

f. Maintenance log

- i. Cindy Schafer suggested that the club begin to keep a maintenance log of work that has been completed. This will allow an easier transition in-between board members. Jay and Aneysa will create a spreadsheet that everyone can add to and update weekly.

g. Horsemanship Clinic

- i. Cindy Schafer suggested that the club hold a mandatory horsemanship clinic for all gymkhana members. The club members were concerned that members would not attend if required to do so. Pauli stated she would be willing to put on a couple clinics throughout the year.

h. Contracts

- i. It was mentioned that we will need a rental arena contract and a cattle contract written for the upcoming year. Jay Guiliams stated is working on both of them.

i. Volunteer Hours

- i. Wallace made a motion to change our volunteer hours required to 10 hours per family membership or 5 hours per individual membership. Each volunteer activity will count as X amount of hours. Pauli Boyd stated she would come up with a spreadsheet to keep track and calculate the hours completed. The motion was seconded by Stephanie Guiliams.
Vote: Unanimous

7. Adjournment

- a. Jake Colletti made a motion to adjourn the meeting at 8:37 PM. The motion was seconded by Stephanie Guiliams.
